1. 2. This proxy form must be submitted in the following manner:

in each case, preferably before **Friday, 18 August 2023** for planning and processing purposes. Appointment of proxies via proxy forms will not be disregarded so long as they reach us by the deadline of **10:00 a.m. on Thursday, 24 August 2023**.

3. DPH shall be entitled to reject the proxy form if it is incomplete, improperly completed or illegible or where the true intentions of the appointor are not ascertainable from the instructions of the appointor specified in the proxy form.
4. By submitting an instrument appointing a proxy to vote at the AGM and/or any adjournment thereof, a member of DPH consents to the collection, use and disclosure of the member’s personal data by DPH (or its agents or service providers) for the purpose of the processing, administration and analysis by DPH (or its agents or service providers) of the appointment of the proxy for the AGM (including any adjournment thereof) and the preparation and compilation of the attendance lists, minutes and other documents relating to the AGM (including any adjournment thereof), and in order for DPH (or its agents or service providers) to comply with any applicable laws, regulations and/or guidelines.
